NWS Awards Presentation recognises outstanding employees and teams

Tsang Yam Pui, Executive Director of NWS Holdings, said at the ceremony, "We recognise the outstanding achievements of our staff through various initiatives, cultivating a people-oriented and strive for excellence corporate culture. I believe that these successful role models will stimulate fellow members of staff and encourage them to deliver enhanced customer satisfaction and create value for stakeholders."

The winners of the first Outstanding Team Grand Awards came from Hip Hing Construction Co., Ltd. (Hip Hing), Guangzhou Huanlong Expressway Co. Ltd and Vibro (H.K.) Limited respectively. Their persistence in striving for improvement has won numerous industry accolades including the Gold Award in the Considerate Contractors Site Award Scheme, jointly organized by the Development Bureau and Construction Industry Council, for three consecutive years.
